COMPANY POLICY FOR CLIMATE CHANGE CONTAINMENT

Solo Cose Buone srl is committed to adopting virtuous practices for the reduction of greenhouse gas emissions in order to contribute, as far as it can, to the containment of climate change.

As part of the improvement activities, including environmental, in past years, the company has already taken actions aimed at reducing greenhouse gas emissions and in particular:

- Action to reduce DIRECT GREENHOUSE GAS EMISSIONS OF SCOPE 1, through substitution, in the year 2022, two obsolete air conditioning systems of the packaging department with more efficient heat pumps and operating with refrigerant gas with less impact on the environment, thanks to a lower GWP (Global Warming Potential);
- reduction of DIRECT GREENHOUSE GAS EMISSIONS OF PURPOSE 1, by replacing in 2017 all the old kilns in the production and cooking department which are obsolete, with more efficient plants that allow lower consumption, with less impact on the environment related to methane combustion;
- Reduction of OBJECTIVE 2 INDIRECT greenhouse gas emissions associated with energy consumption as a result of energy efficiency linked to:
 - purchase and installation, in the year 2023, of low-consumption LED luminaires to replace traditional lighting by neon lamps (relamping), at the entrance, offices, dressing rooms and packaging department.
 - replacement in 2022 of the old air compressor for the operation of machines and plants, with a new super-silenced rotary screw compressor with inverter, more efficient.

Future objectives include the replacement of office and production and cooking windows with new energy-efficient fixtures, with a predictable energy saving and consequent reduction of the methane consumption of the boiler for heating offices (action to reduce DIRECT GREENHOUSE GAS EMISSIONS OF PURPOSE 1) and the Electricity consumption for the operation of heat pumps (action to reduce INDIRECT GREENHOUSE GAS EMISSIONS OF PURPOSE 2).

At the beginning of the year, when the management of the Food Quality and Safety Management System reviews the progress of the improvement programmes and activities in the current year, Also assessing any improvements achieved in environmental sustainability, and in particular in the management of climate-preserving gases. In this context, the Directorate also defines future objectives and improvement activities/programmes to achieve them, renewing its commitment to evaluate the possible adherence to new practices aimed at reducing the effects of climate change, in agreement with its stakeholders.
